Objective	To increase Parish Councils awareness of the Parish Council Code of Conduct
Action Taken	<p>Note that changes to the Localism Act in relation to the Code of Conduct were confirmed to the Clerks:</p> <ul style="list-style-type: none"> ❑ 3 February 2012 – letter sent to Parish Clerks about all the new requirements under the Localism Act and consulting on what Parish Councils wanted in new Code. Asked for comments before 29 February 2012 for a Monitoring Officer discussion on a Cambridgeshire draft Code or for Standards Committee, by 31 March 2012. One Parish Council responded. ❑ In May 2012, had been informed that there was likely delay in implementation – until October 2012. Clarification sought from DCLG in May. Stated intention to implement but Regulations not ready, but intended implementation date 1 July 2012. ❑ On 6 June 2012 – update provided to Parish Councils about this issue warned that new provisions may need to be in place from 1 July. ❑ Disclosable Pecuniary Interest Regulations notified to Council on 8 June. ❑ On 12 July - notification of this sent to the Parish Clerks – explained process for Code adoption at ECDC and about NALC version of the Code. ❑ 6 July 2012 – explanation of the process on the Code sent to Parish Councils again and explanation of the District Council's procedure for adoption via Council on 26 July 2012 & form for dispensation sent. ❑ 27 July 2012 – notification to Parish Councils of the adoption and copies of the Code and other documents sent to Clerks. Documents and advice on Code provided since then. ❑ Notification of training sent to all Parish Clerks to arrange 9 sessions at local Parish/Town venues covering the Neighbourhood Panel configurations of Parish Councils (and one additional early session held in September at Grange). One of 9 sessions cancelled – covering the Brinkley/ Burrough Green/ Dullingham/ Stetchworth <i>due to lack of sufficient interest</i> (scheduled for 8 November 2012). All Councillors were welcome to attend any of the sessions across the District and were notified accordingly. ❑ Pocket guide to the Code distributed to all Councillors who attended training. ❑ Full guide to Code available on the District Council website and Clerks notified of this. <p>Principal Democratic Services Officer explained what engagement there had been with Town and Parish Clerks and the 9 training sessions proposed across the District between September – November 2012 at the last Panel meeting.</p>
Current Situation	All training sessions completed. Circa 40% of Clerks and Councillors across District have attended one of the training sessions. No further sessions proposed.

2. Waste and recycling bid is a winner

East Cambridgeshire District Council has successfully won a £5 million bid from Central Government to fund a new recycling service and retain weekly waste collections.

The funding, from the Department for Communities and Local Government's 'Weekly Collection Reward Scheme', means residents will find it easier to recycle more of their waste with the new service being introduced in late 2013 or early 2014.

The current brown sack and black box collection system will be replaced with:

- * A new wheeled bin recycling collection, including paper, glass, metal cans, plastics, cartons and cardboard. This will be collected fortnightly.
- * A new wheeled bin collection for organics to include food and garden waste. This will also be collected fortnightly.
- * A fleet of new vehicles for the new services as well as a rescheduling of rounds to reduce carbon emissions.

The weekly waste collections would be retained and collected via black sacks.

The work to put in place the new system will include a survey of all households in the district to identify anyone whose property would not be suitable for the new service. These homes would retain the current black box and brown sack collection service while other households would convert to the wheeled bin service.

Councillor Richard Hobbs, Chairman of the Community and Environment Committee at East Cambridgeshire District Council, said: "Winning the funding to improve our recycling service is fantastic news. In a recent public consultation we had overwhelming support for our plans so it is great to know we can now deliver a recycling service which people want.

"The task ahead of us now is to bring the service in as soon as we can. This will mean a lot of hard work from buying the vehicles and wheeled bins to deliver the service to identifying the homes which will not be suitable for the service. We hope to complete this by next summer and have the service up and running from late 2013 or early 2014. During this process we will ensure residents are kept fully up to date with the progress of our work. Finally I would like to thank the Environmental Team at the District Council who has made our bid successful. It is very exciting to know our recycling rates are set to rise and we can continue to collect black bag rubbish every week in the years to come."

Fly Tipping Enforcement Options

Investigation	Inspection of fly tip for evidence that could lead to enforcement action being taken, together with related enquiries.
Warning letter	Used where formal enforcement action is not considered appropriate as a warning of the potential consequences of further infringements.
Statutory Notice	A legal requirement to provide information that will assist with investigation of an offence.
Fixed Penalty Notice	Agreement to accept a standard penalty fee as an alternative to formal legal action.
Duty of Care Inspection	Check that a business has correct arrangements in place for the storage, transport and disposal of its waste.
Stop & Search	Check on vehicle carrying waste for waste carriers licence and waste disposal documentation.
Formal Caution	An offender having admitted an offence is formally cautioned by the Head of Service. A record is kept of the Caution for 5 years.
Formal Caution With Costs	As Formal Caution, but investigation and clear up costs are charged to the offender.
Prosecution	Formal prosecution through the Court System.

Sanctuary Housing – Action Updates:

Current issues:

The Government is reducing the amount of housing benefit some people can claim.

If you claim housing benefit to help pay your rent you may be affected by changes from April 2013. The changes mean that some people will get less housing benefit than they did before.

From April 2013, if you live in a council or housing association home and you have one or more 'spare' bedrooms your housing benefit may be reduced.

This could affect you:

- if you are 16 to 61 years old
- even if you only get a small amount of housing benefit – for example, if you are working
- even if you are sick or disabled

You won't be affected if:

- you live in a one bedroom flat or bedsit, or if
- you or your partner are old enough to receive pension credits.
- In April 2013 the pension credit age will be around 61 years and 6 months

The new benefit rules will apply from April 2013, so now is the time to get help and support.

What is a 'spare' bedroom?

Under the new rules if you have more bedrooms than the Government says you need, you will lose part of your housing benefit. The new rules mean you will be allocated one bedroom for:

- each adult couple

- any other person aged 16 or over
- two children of the same sex under the age of 16
- two children under the age of 10 regardless of their sex
- any other child
- a carer (who does not normally live with you) if you or your partner need overnight care.

It does not matter how the 'spare' bedroom is used, the new rules will apply even if:

- you and your partner need to sleep apart because of a medical condition
- the main residence of your children is another address, but you have a spare room for when they stay with you.

What happens if you have a 'spare' bedroom?

If you have one 'spare' bedroom your housing benefit will be cut by 14% of the rent you pay every week. If you have two or more spare bedrooms, you will lose 25%. If your benefit is cut you will have to pay your landlord the difference between your housing benefit and your rent.

Limit on benefits

From April 2013, the overall amount of benefit you can receive will be capped. The Government will add up how much money you get from a range of benefits, including: housing benefit, jobseeker's allowance, employment support allowance, child benefit, child tax credit and carer's allowance.

If the total comes to more than the maximum amount allowed your housing benefit payments will be reduced.

The maximum amount of benefit you will be able to receive from April 2013 will be:

- £500 per week for single parents
- £500 per week for couples with or without children
- £350 per week for single people without children.

This will not apply to you if:

- you get pension credit or working tax credit
- a member of your household is claiming disability living allowance, attendance allowance or the support element of employment support allowance.

If you are worried about being able to afford to pay your rent from April 2013 you should ask for advice now. If you don't pay your rent you could lose your home, so talk to your landlord about different ways to pay. You can also:

- Talk to your landlord about transferring to a smaller home or taking in a lodger
- Contact your council to ask about extra financial help. Councils have a limited amount of money available to make discretionary payments towards housing costs. Your council may prioritise your claim if you have a disability and your house has been adapted.
- Get in touch with your local citizens advice bureau (www.citizensadvice.org.uk) or other local advice agencies
- Make sure you are claiming all the benefits you can – for example, money to help with the costs of a disability
- Try to find some paid work to increase your income
- Get more information about the cap on benefits by calling the Government's information line on 0845 605 7064.

Do you have a disability and need overnight care?

If you are of working age, have a disability and need a 'spare' bedroom so that a carer can stay overnight you should contact your local council now so that staff can help you keep more of your housing benefit.

Changes to council tax benefit

From April 2013, if you are of working age and claim council tax benefit, the amount of support you receive may be cut. This is because the Government is reducing the amount of money available and asking local councils to run their own schemes, which may vary from area to area. Contact your local council for details.

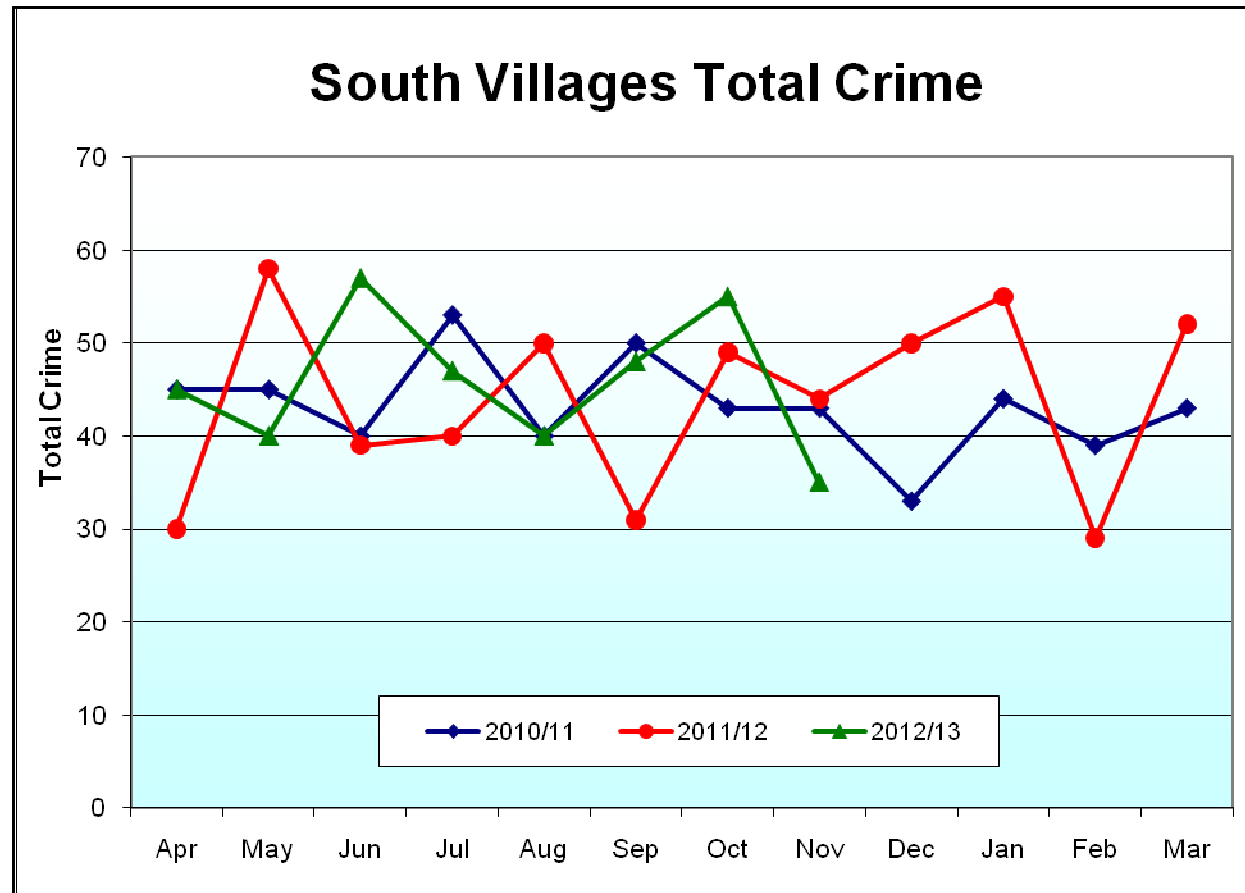

Objective	To reduce speeding and parking offences as detailed under 'other issues' below
Action Taken	<p>Speed enforcement and Speedwatch activity has taken place across the area.</p> <p>A1303 Stetchworth Toll, Newmarket – 6 Fixed Penalty Notices (FPNs), 2 Process, 27 Speed Awareness Courses offered B1061 Dullingham Road, Newmarket – 5 FPNs, 13 Speed Awareness Courses Bell Road, Bottisham – 5 FPNs, 41 Speed Awareness Courses Newmarket Road, Burwell – 2 FPNs, 24 Speed Awareness Courses Swaffham Road, Burwell – 3 FPNs, 26 Speed Awareness Courses Ness Road, Burwell – 1 FPN, 1 Speedwatch letter, 5 verbal warnings</p> <p><u>Speedwatch Activity</u></p> <p>High Street, Brinkley – 2 letters sent High Street, Cheveley – no speeding vehicles observed</p> <p>Parking patrols continue in areas highlighted, though few offences were observed in these specific areas. In other areas tickets have continued to be issued for unnecessary obstruction, parking on double yellow lines, and vehicles without valid tax discs. The main parking problems continue to be around schools at dropping off and picking up time. PCSOs have been continuing with patrols outside schools, but have been confronted by parents who've claimed it's not an offence to park illegally if you're dropping your children off, and others who've demanded police vehicles be moved, so that they can park closer to the school.</p>

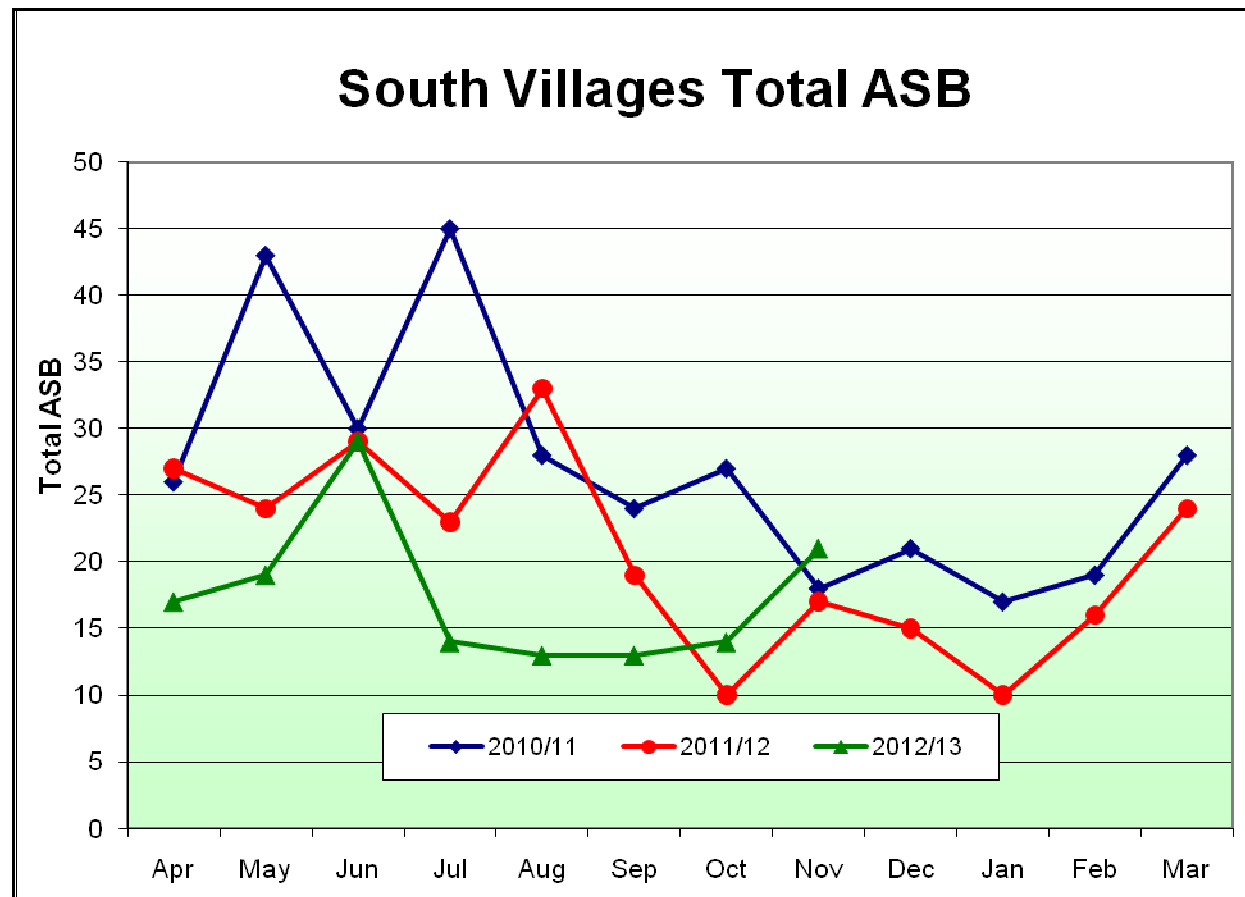
