### **Draft Ely Station Gateway Supplementary Planning Document – Public Consultation**

The District Council will be consulting on the draft Ely Station Gateway Supplementary Planning Document (SPD) from Monday 27<sup>th</sup> January – Friday 21<sup>st</sup> March 2014.

The Draft Ely Station Gateway Supplementary Planning Document (SPD) sets out ambitious proposals to transform the station area into a vibrant mixed use urban quarter which provides for employment expansion, enhanced transport interchange facilities as well as creating an attractive gateway to the city.

### **Better Care Fund**

The County Council is consulting on the Better Care Fund, a new pooled budget which aims to improve health outcomes in Cambridgeshire.

The Better Care Fund is a new pooled budget for Clinical Commissioning Groups (CCGs) and councils to join-up health and care services. Previously known as the Integration Transformation Fund, it will help to integrate work and transform local services to older and disabled people.

It is being proposed to use the fund in Cambridgeshire to re-design how health and social care across the county is currently delivered. In the future, the focus will be more on working to prevent people requiring health and social care services and, where they do, being more proactive in identifying people who are at risk and having more joined up and active care plans. The aim, where ever possible, will be to help people to stay at home and remain independent for as long as possible.

This is a large and complex programme and the Better Care Fund will, if successful, re-shape drastically the way services are provided in Cambridgeshire.
