ENP12/30 Welcome

Cllr Philip Eden, the Panel Chairman, welcomed everyone to the meeting.

ENP12/31 Introductions and Apologies

The Panel Members and supporting officers introduced themselves to the meeting. Apologies were received from Councillors Sue Austen, Lindsay Harris and Richard Hobbs.

ENP12/32 Chairman's Announcements and Consultation Items

Councillor Philip Eden highlighted the items currently out for consultation: (a) Ely's Car Parking, reminding everyone that the consultation closed on 1st March; (b) the Independent Remuneration Panel Review of Members Allowances at the District Council; and (c) The District Council's new Local Plan, which would be open for comments from February.

ENP12/33 Update on East Cambs District Council Actions Since Last Meeting

The Panel received a table giving an update on the actions undertaken by East Cambs District Council.

Issue No and Description	Further Comments
St Marys Car Park	Work on this was imminent.
Ely Environmental Action day	A report on the Action Day had been posted on the District Council's website. The District Council's website would be updated about issues reported back to the Panel.
Recycling Collection Plans for Wheelie Bins	The forward plan for implementation of the new collection scheme would be reported to the next Panel meeting.
The Maltings	A market testing exercise had been undertaken for a new provider who would be able to offer an all year service. Discussions were ongoing about public access to the lobby and meeting rooms. The Council had committed to improving the facilities.

Waste and Recycling Bid	A bid to fund a new recycling service whilst retaining the weekly collection service had been successful in securing £5million.

The Panel received a table giving an update on the actions undertaken by the Police. Priorities from the last Panel meeting were: 1) car parking and 2) riverside anti-social cycling.

Issue No and Description	Further Comments
Car Parking	Parking enforcement continued. Frequent patrols had taken place, resulting in the issue of 49 tickets. This was an ongoing issue and would need a multi-agency approach to be dealt with.
Riverside Anti-Social Cycling/The Cutter	Patrols have been carried out and riders spoken to.
Beresford Road and St Johns Road	A new 'safer schools' scheme was being developed to tackle this.
Dolphin Lane – cyclists	No further reports of incidents.
Princess of Wales Hospital – parking	Patrols had been carried out. No offences witnessed.
Forehill – Blue Badge holders	No driver reported for abusing the scheme. Complaints about obstruction by drivers parking in Forehill were difficult to prove. Blue Badge holders were allowed to park on double yellow lines but not in loading areas.
Operation Wicket	This operation had targeted theft from shops, with high visibility patrols taking place over the Christmas period. 20 people had been caught and 3 imprisoned.

Crime Figures	There had been a significant reduction in the crime
	figures, from the same time last year, in Ely and across

Inspector Ormerod replied to a number of public questions by stating:

- There was concern over the issue of cyclists riding without rear lights. Rather than issue tickets, the riders would be warned and had to report to a police station to prove they had purchased rear lights for their bike.
- There had been no previous reports of cyclists biking up the wrong way in The Gallery, Market Street and High Street.
- Other areas were monitored for illegal parking and tickets had been issued.
- If there were specific areas which were suffering from speeding, it would be useful to know so the safety camera van could be deployed.

ENP12/39 Community Infrastructure Levy

Shirley Blake advised the Panel about the introduction of the Community Infrastructure Levy (CIL). Developers had to pay the District Council money to help fund infrastructure requirements as a result of the impact of their developments. The CIL was a new tool, introduced by Government, that allowed local authorities to make a charge on developers. CIL would be a standard charge paid at the commencement of a development. It would not replace Section 106 payments altogether and would be introduced on 1st February 2013. CIL would only be charged on residential or retail developments.

At least 15% of CIL income would be passed to parish councils. It was difficult to anticipate exactly how much income would be generated over the next 20 years. The CIL funds could be pooled together for infrastructure within the district. The benefits of CIL included the delivery of infrastructure, flexibility at a local level, developers would be more certain of their contributions and transparency about how the contributions would help the community.

In answer to public questions, it was revealed that CIL related to the floorspace for all storeys of a building and not its footprint. A comparison had not been done between potential CIL and previous Section 106 incomes. CIL and Section 106 could both be used on a development. House extensions under 100m² would not be subject to CIL. CIL would vary between councils as it would depend on local land values.

ENP12/40 Update on Option B for the Bypass

Alistair Frost advised the Panel about the progress towards the Ely bypass. Option B was the one that people wanted, as demonstrated by the 61% support for it compared to the other options and a further consultation, which had shown 81% support for Option B. This had gone to the County Council's Cabinet, which had agreed to go forward with Option B. However, this decision had been called in by one of the County Council's scrutiny committees. It had looked at the issue to ensure enough work had been done on the options. It agreed to go with Option B but asked for additional information to be made available for the public. Subsequently Cabinet approved to a pre-planning consultation and to make a planning application.

This approached was supported by the rail industry and by Ely Cathedral Chapter. However, the Chapter suggested options for a 'hidden bypass' with several routes cutting across the land off Angel Drove, going under the railway line and along the Kings School sports fields. Routes 1 and 2 had many technical limitations and would mean that land would have to be found to replace the sports fields. Route 3 was being looked at as no technical design had been completed for this. These would be included as an addendum and used as part of the public pre-planning exhibition to be held in March 2013. It was intended to submit a planning application and publish draft Orders in June.

The Chairman requested a further update for the July Panel meeting.

ENP12/41 Panel Prioritisation

The Chief Executive of East Cambridgeshire District Council summarised the various issues brought up during the Audience Issues discussions.

For immediate action:

- Invite the Police and Crime Commissioner, or his Deputy, to attend a future Panel meeting;
- Send out a letter relating to the road conditions in the Chantry;
- Deal with the damaged lamp standards in the Market Place;
- Clear out-of-date posters and other fly-posting.

Updated information wanted on:

- The contact point to report contraventions of Blue Badge holders parking;
- The station hub;
- Trading on pavements;
- The Environmental Action Day.

Work for the City of Ely On-Street Working Party:

Forehill parking restrictions.

Emerging priorities:

- Speeding in various locations;
- Highway safety issues including the Chapel Street/Downham Road junction, traffic lights in Lisle Lane, signage in the Lynn Road/Market Street/The Gallery area;

Police priorities:

Continued car parking enforcement;

• The use of uniformed police presence.

ENP12/42 <u>Ely Foodbank</u>

The Chairman permitted Alan Williams to report on progress with the Foodbank. So far 7 tons of foodstuffs had been donated. This had allowed 350 families to benefit in the short term. A request was made for people to continue to support this, as the Foodbank was increasingly busy. It aimed to cover an area within a 15 mile radius of Ely, so a lot of work was still needed.
